



APPLICATION FOR INTERNATIONAL GRANTS FOR CHILDREN WITH PRIMARY IMMUNODEFICIENCIES

Patients with a confirmed diagnosis or suspected PID who live in another country outside Spain or Spanish PID patients who need treatment abroad, may benefit from an International grant provided by the BCN-PID Foundation to assist their PID-related treatment. The total amount allocated to these grants will be **3.000 euros per year** divided into **3 grants of 1000 euros** each.

REQUIREMENTS TO RECEIVE GRANTS:

- Patient under 18 years of age.
- Confirmed or suspected diagnosis of PID
- Not receiving support for the same reason from other entities

TYPE OF FINANTIAL SUPPORT:

- 1000 Euros to be deposited directly into the bank account of the family.

DOCUMENTATION FOR YOUR APPLICATION:

- The International grant application form (completed and signed) provided by the BCN-PID Foundation.
- Patient's clinical report.
- Family social report.
- Acceptance letter from the hospital that will receive the patient.

The personal data provided will be collected in a file for which the Barcelona Foundation for Primary Immunodeficiencies in Pediatrics is responsible, with address at Avinguda Diagonal, no. 467, 5th 2nd, Barcelona. This file responds to the needs of registration, concession and follow-up of the scholarships and training programs for which an application has been submitted. We can also use them to continue informing applicants of future aid programs and other Foundation activities.
